Re: Proposed Chemical Treatment for Eurasian Watermilfoil in Reservoir Pond, Little Horn Lake, and Townsend Flowage, Oconto County, Wisconsin

Dear Reservoir Pond, Little Horn Lake Property Owner or Occupant:

The Townsend Flowage Protection District and Inland Lakes Protection & Rehabilitation District, with support from the Wisconsin Department of Natural Resources (the WDNR) and Wisconsin Lake & Pond Resource, will be assessing and chemically treating areas of Eurasian watermilfoil, in Reservoir Pond, Little Horn Lake, and the Townsend Flowage. Areas to be treated include up to 10.2 acres on Little Horn, 232.54 acres on Reservoir Pond, and 205.18 acres on Townsend Flowage.

A copy of the permit application is included and details the location of proposed treatment areas. Proposed treatment areas were identified based upon the presence of nuisance levels of aquatic plants during a recent survey of the lake. Only those areas that are designated in the permit application will be treated with the final determination of where treatment may occur to be made by the on-site WDNR supervisor.

The proposed treatment is going to take place in May-June depending on water temperatures and is designed to target specific areas. The area to be treated near your property will be selectively treated to help reduce a nuisance populations of select vegetation. The day treatment takes place a bright yellow sign will be placed on each dock or shoreline within 150' of any of the affected treatment areas. **Areas will be treated with Sonar AS (active ingredient Fluridone). Please read the yellow treatment sign carefully.**

Sonar AS Treatment: There are NO water use restrictions. Lake users are able to use the treated water for any recreational activity (boating, swimming, fishing, etc.), irrigation, or animal watering purposes without restriction immediately after treatment.

If you have questions or request a current copy of the manufacturers' label for the herbicides to be used for this treatment, please contact Wisconsin Lake & Pond Resource at (920) 872-2032. Neither the Townsend Flowage Protection District nor the applicator can answer specific questions about herbicide use and possible effects other than what is represented on the approved label. 3200-004 Chemical Aquatic Control Application - Lake, River, Pond

- For a large-scale treatment, attach evidence that a public notice has been published in a regional / local newspaper and if required that a public informational meeting has been conducted as defined in NR107.04(3).
- Pay fee online.
- Sign and Submit form.
- A signed permit application certifies to the Department that a copy of the application has been provided to any affected property owner's association/district and to landowners adjacent to treatment area.

Applicant Responsibilities and Certification

- 1. The applicant has prepared a detailed map which shows the length, width and average depth of each area proposed for the control of rooted vegetation and the surface area in acres or square feet for each proposed algae treatment.
- 2. The applicant understands that the Department of Natural Resources may require supervision of any aquatic plant management project involving chemicals. Under s.NR 107.07 Wis. Adm. Code, supervision may include inspection of the proposed treatment area, chemicals and application equipment before, during or after treatment. The applicant is required to notify the regional office 4 working days in advance of each anticipated treatment with the date, time, location and size of treatment unless the Department waives this requirement. - 3. The applicant agrees to comply with all terms or conditions of this permit, if issued, as well as all provisions of Chapter NR 107, Wis. Adm. Code. The required application fee is attached.
- 4. The applicant will provide a copy of the current application to any affected property owners' association inland Lake District and, in the case of chemical applications for rooted aquatic plants, to all owners of property riparian or adjacent to the treatment area. The applicant has also provided a copy of the current chemical fact sheet for the chemicals proposed for use to any affected property owner's association or inland Lake District.
- 5. Conditions related to invasive species movement. The applicant and operator agree to the following methods required under s.NR 109.05(2), Wis. Adm. Code for controlling, transporting and disposing of aquatic plants and animals, and moving water:
 - Aquatic plants and animals shall be removed and water drained from all equipment as required by s.30.07, Wis. Stats., and ss. NR 19.055 and 40.07, Wis. Adm. Code.
 - Operator shall comply with the most recent Department-approved 'Boat, Gear, and Equipment Decontamination and Disinfection Protocol', Manual Code #9183.1, available at http://dnr.wi.gov/topic/invasives/disinfection.html

All portions of this permit, map and accompanying cover letter must be in possession of the chemical applicator at the time of treatment. During treatment all provisions of Chapter NR 107 107.07 and NR 107.08, Wis. Adm. Code, must be complied with, as well as the specific conditions contained in the permit cover letter.

I hereby certify that that the above information is true and correct and that copies of the application shall be provided to all affected property owners promptly and that the conditions of the permit will be adhered to. All portions of this permit, map and accompanying cover letter must be in possession of the applicant or their agent at time of plant removal. During plant removal activities, all provisions of applicable Wisconsin Administrative Rules must be complied with, as well as the specific conditions contained in the permit cover letter.




